COLLABORATION PROTOCOL

between

PUBLIC ADMINISTRATION ACADEMY FROM NEAR THE PRESIDENT OF THE REPUBLIC OF MOLDOVA

and

KARABUK UNIVERSITY, TURKEY

and

"ANDREI ŞAGUNA" UNIVERSITY OF CONSTANȚA, ROMANIA

Preamble

For the development of the research and education process.

For the extension of the academic scientific research, the support of the academic staff and of the students in the evolvement of certain multidisciplinary research themes.

For the initiation and development in partnership of some european projects.

Public Administration Academy from near the President of the Republic of Moldova, Karabuk University and "Andrei Şaguna" University of Constanța agree in establishing a programme of educational and scientific collaboration, of promoting some work rapports, and of extension of the international cooperation.

The central objective of the protocol

Is the continuous perfecting and quality improvement of the education and scientific research process, within and according to the educational strategies of the two institutions.

Article 1

The parts will develop and encourage the exchange of academic staff, students, professional and scientific information in fields of common interest, in terms of mutual benefit and reciprocity. The exchange will include the research, the academic training, the participation to conferences, seminars and symposia as well as other educational and research activities, for which the parts will inform themselves and will reciprocally help in the organizing and development.

The parts will mutually promote the experts of the two institutions by including them in the scientific committees of competition, of the manifestos and of the publications, and through other ways they consider appropriate.

Article 2

Each part will embolden the participation in common research, education and continuous training projects between the collectives and their members. The fields and objectives of these projects will be established through direct protocols in the conditions stipulated in Article 1 and according to a general topic specified in additional documents of the existing collaboration protocol. The additional documents will be signed by the coordinators designated by the two institutions.

The parts will give a priority attention to their partnership in european financed projects.

Article 3

The parts will collectively organize scientific manifestos, will coedit scientific works through their own publishing houses and will jointly organize postgraduate courses, of master's and doctoral studies.

The parts support the exchange of books, periodicals, educational material and scientific publications on the basis of the mutual agreement and in terms of respecting the internal norms applied by each part. Furthermore, they agree to reciprocally help in the development of some educational modules of common interest.

Article 4

The parts will mutually support, in the development of new research projects and new educational programmes, having as purpose the pliability of both processes as well as the increment of the degree of attractiveness in relation to the external partners and the target group.

Article 5

The present Protocol is established for a five-year period, starting from the signing date and can be renewed. The non-renunciation to the Protocol at its due date indicates a tacit prolongation agreement for another period of five years.

The Protocol can be modified or augmented only with the written approval of both parts.

Article 6

The present protocol of collaboration was signed and will enter into force on the 24th of October 2013.
