

**AGREEMENT OF COOPERATION
BETWEEN
ACADEMY OF PUBLIC ADMINISTRATION
AND
PETRO MOHYLA BLACK SEA STATE UNIVERSITY**

Preamble

Pursuant to the rules of mutual respect, independence and taking into account the mutual benefits, Academy of Public Administration, Moldova represented by the rector Oleg BALAN and Petro Mohyla Black Sea State University, Ukraine represented by the rector Leonid KLYMENKO, hereinafter referred to as "parties" have decided to enter into an agreement on cooperation in order to encourage joint scientific research and an academic exchange in all fields represented on those universities and declare as follows:

Article 1

The parties undertake to treat this agreement in a privileged way.

Article 2

The parties decide to develop the following collaborative activities in the academic areas of mutual interest:

- joint research and / or teaching activities
- exchange of research and teaching employees as well as university administration staff
- exchange of students within undergraduate and graduate studies
- exchange of information, materials and scientific publications in the fields within the area of both universities' interests.

Article 3

Cooperation shall take place between respective faculties, institutes or departments of the Academy of Public Administration and their equivalent units at the Petro Mohyla Black Sea State University.

Article 4

This Agreement shall be used as the basis for developing working programs of fulfillment of the specific tasks. These working programs shall detail kind of an activity, its duration and number of participants.

Article 5

Costs related to the execution of this agreement shall each time be a subject of negotiations and shall be determined in separate annexes.

The following division of cost shall be adopted regarding the employee exchange:

- delegate university covers the travelling expenses
- host university covers the cost of stay

It is also understood that all financial arrangements will depend upon the availability of funds and will be administered in accordance with each institution's usual practice and rules.

Article 6

Both parties shall make every effort to raise funds from various sources to support joint projects.

Article 7

The parties agreed that the medical and accident insurance expenses during the stay of any exchange staff or student will be covered by the respective participant in the exchange programme.

Article 8

Fulfillment of this Agreement shall be entrusted to International Relations Offices at both parties.

Article 9

This Agreement has been drawn in languages: Romanian – one copy, Ukrainian – one copy and English – two copies, with the same binding power.

Article 10

The Agreement comes into force as of the day of signing of both parties and shall be concluded for an unlimited period. All exchanges require mutual consent. Both parties reserve the right to cancel this Agreement observing a 6-month period of written notice.
